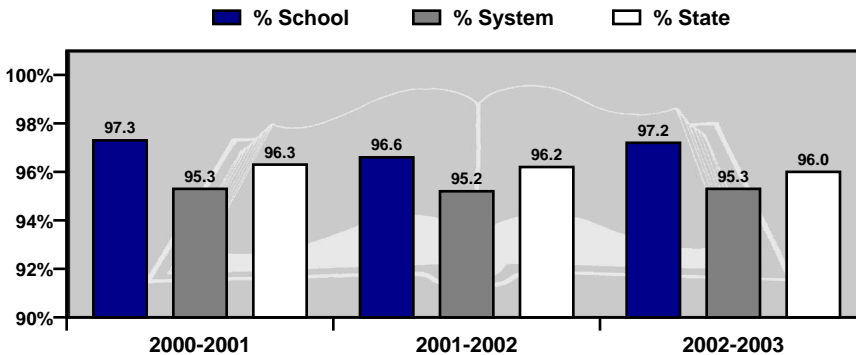

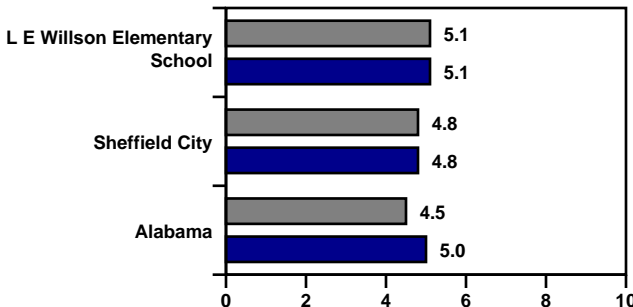
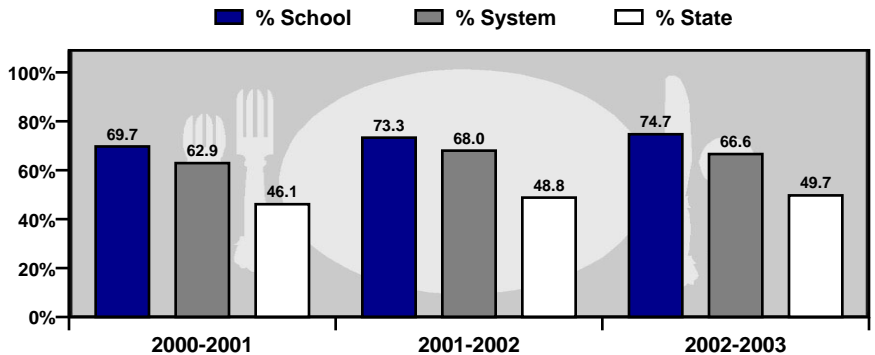


## Average Daily Attendance

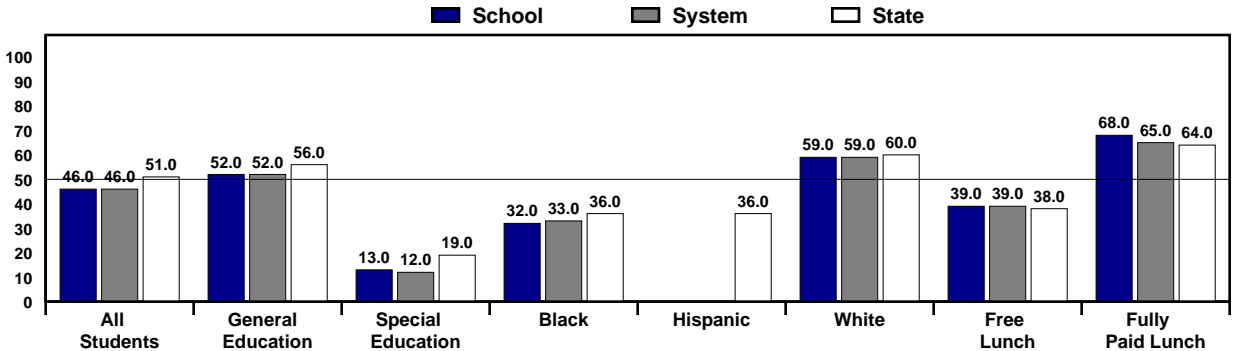
## Stanford Achievement Test 2003

Average Percentile Across Grades and Subjects



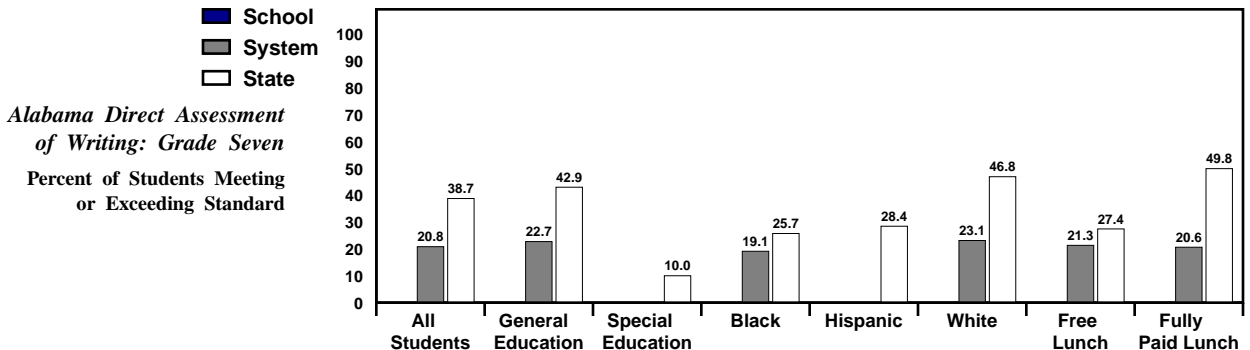
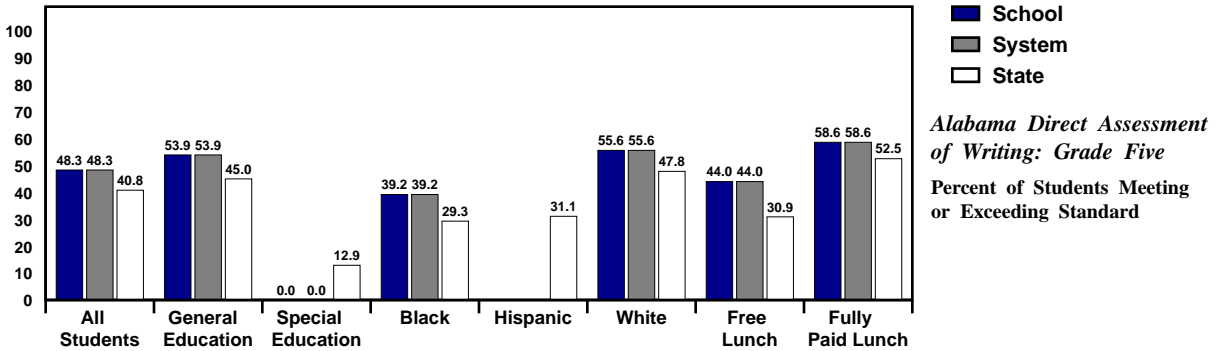

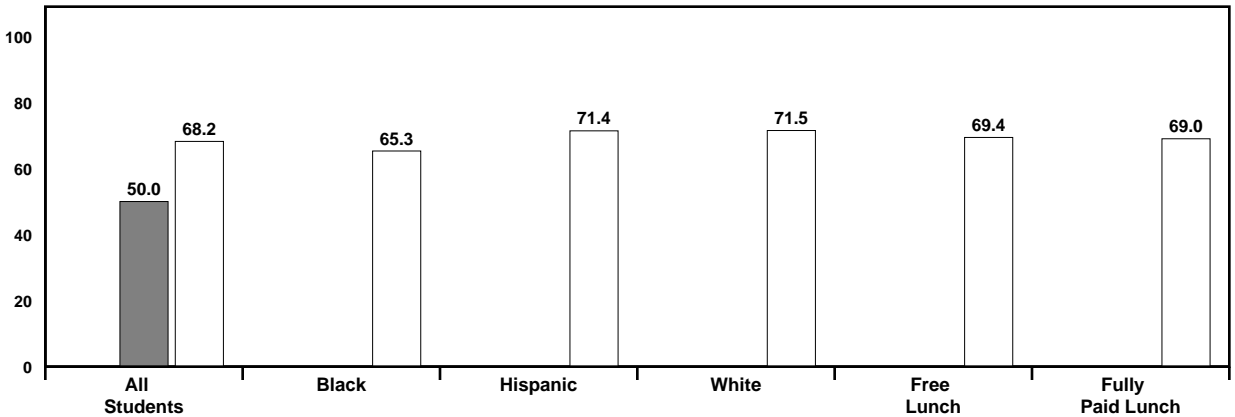
# STUDENT ACADEMIC PERFORMANCE

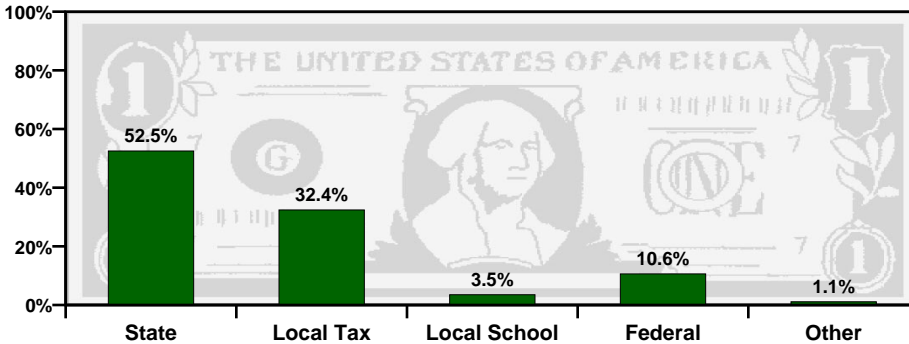

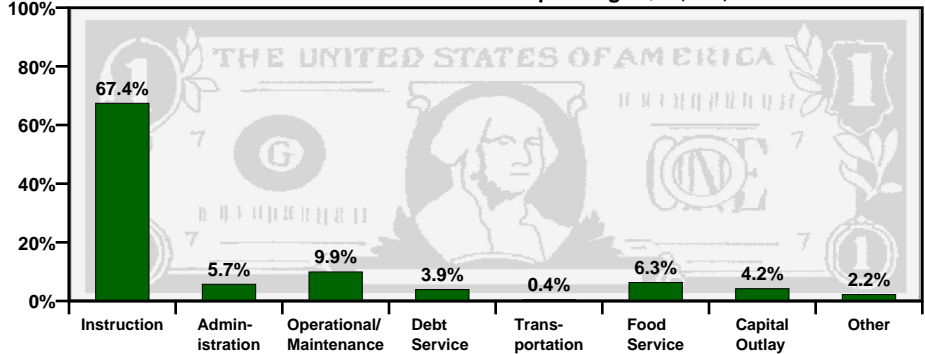
