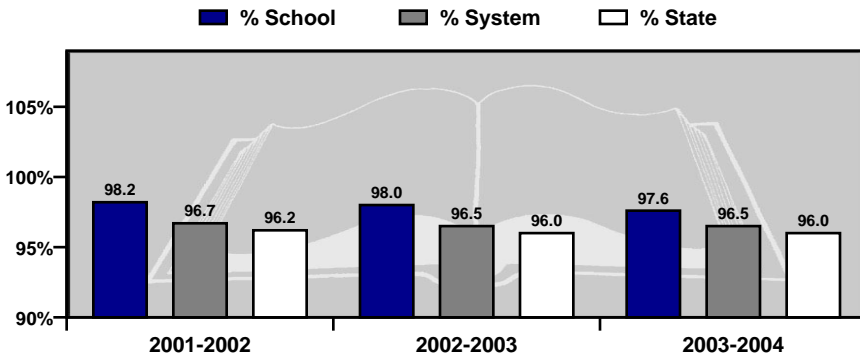

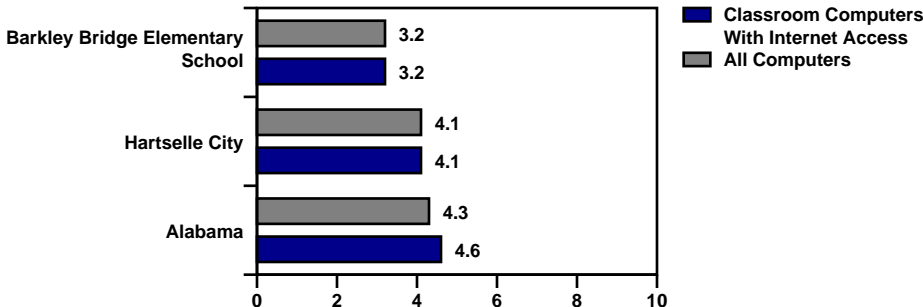
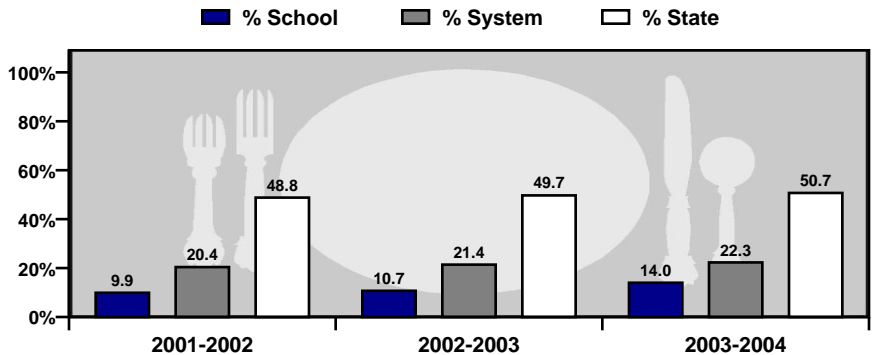


Average Daily Attendance

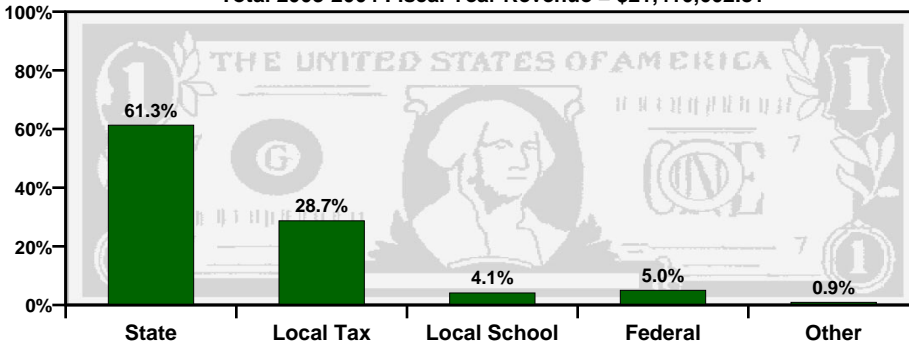
Alabama Direct Assessment of Writing 2004

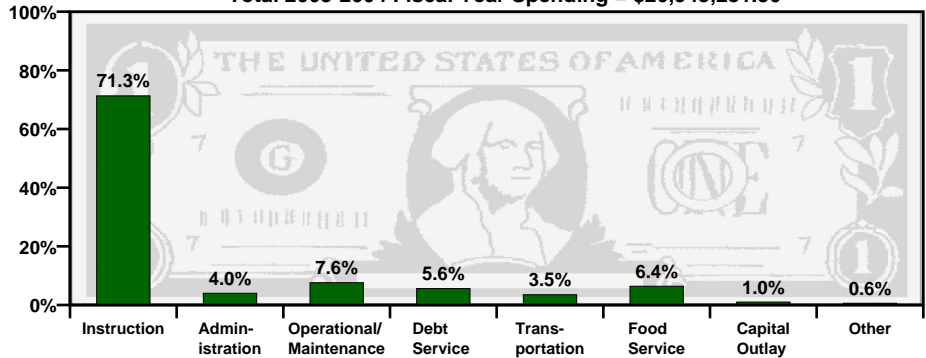
Total 2003-2004 Fiscal Year Revenue = \$21,410,602.81
