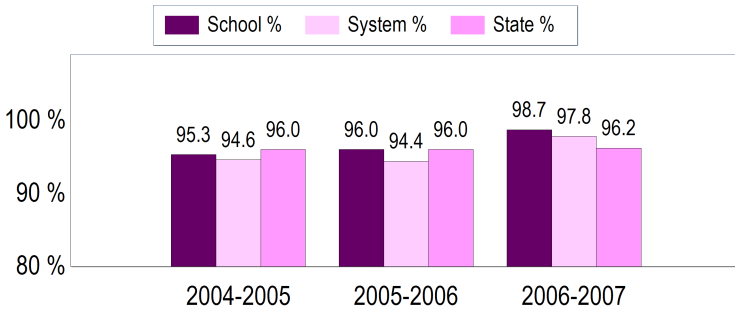

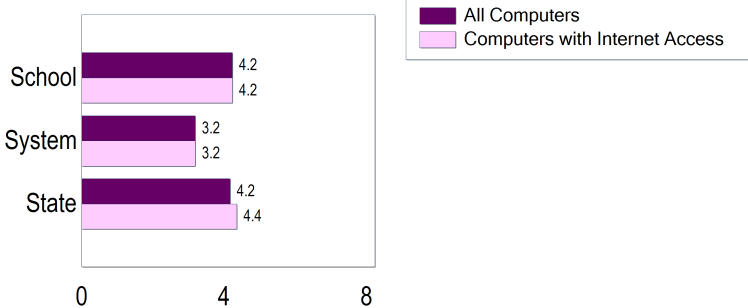
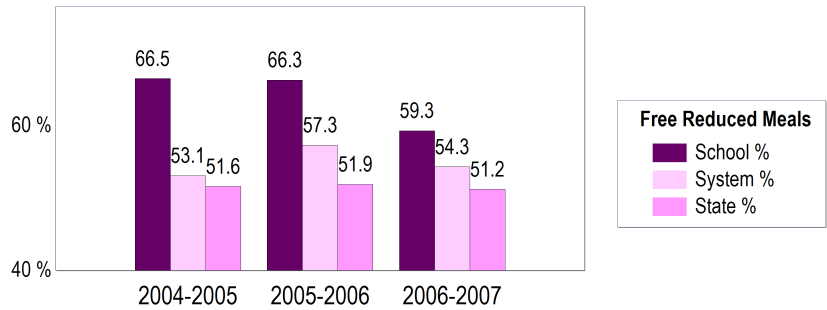


Average Daily Attendance

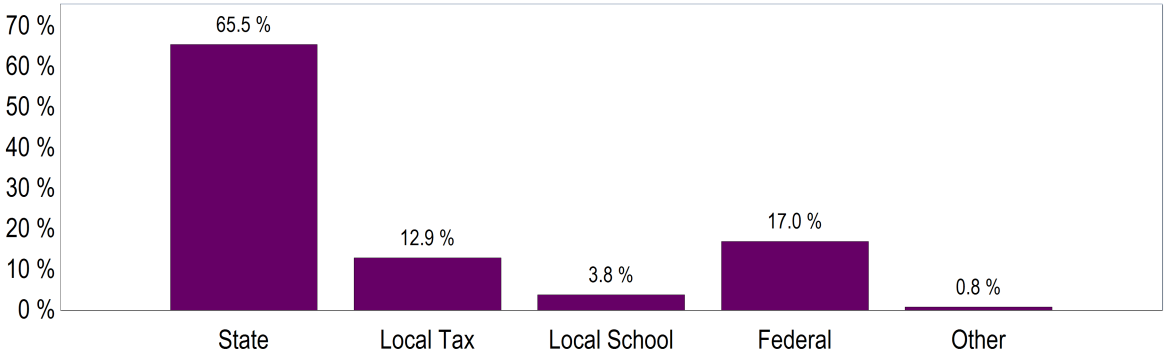

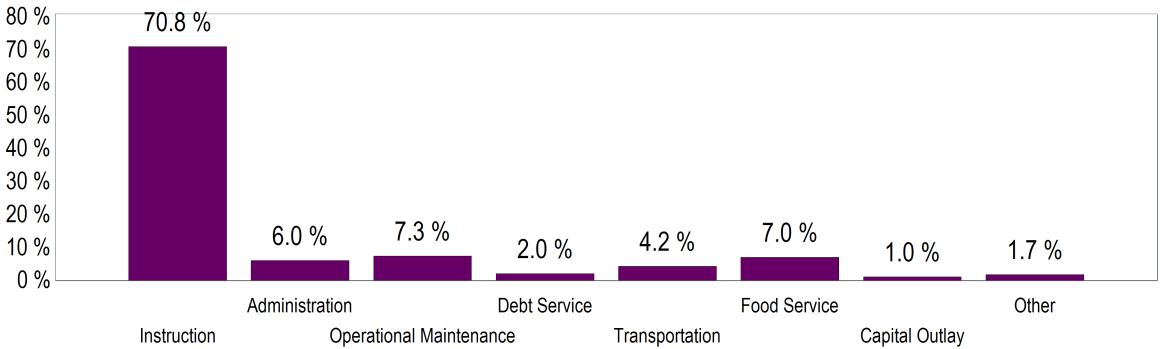
Total 2005-2006 Fiscal Year Revenue = \$11,187,535.45
